From 14 to 25 March 2022, SCA noted that a virtual session was held to review the (re)accreditation of 15 NHRIs around the world, four of those assessed were members of ENNHRI, at the October 2022 session Cyprus, Great Britain, Norway, Northern Ireland and Turkey. Announced that five more ENNHRI members, including Austria re-raised it from B to A status. Germany received a postponement to the second SCA session of 2023, with the recommendation to take the necessary measures to address the recommendation regarding the duty to protect, including the capacity to monitor and access places of deprivation of liberty. Hungary has been downgraded to B status with an emphasis on combating human rights violations, selection, appointment and recommendations for cooperation with civil society.
