- On 22.01.2026, the Council of Europe's European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) published a statement following its visit to France, where it once again deplored severe prison overcrowding and deteriorating conditions in places of detention. The Committee visited 14 police and gendarmerie detention facilities, four prisons, and the Valentine-Marseille detention centre for children, noting significant overcrowding and related hardships. In its response, French authorities outlined plans to strengthen training for law enforcement, prison, and healthcare personnel and carry out renovations and improvements to address the issues highlighted by the CPT.
