## UN Development Programme (UNDP)

The complainant, who is deaf, contacted Griffith College about enrolling in a course designed to prepare students for the exams, which can lead to qualification as a barrister. In an email to Griffith College, complainant asked the College whether it would provide her with ISL interpretation and notetaking to enable her to access the course on an equal footing with other students. Griffith College responded by email the next day saying that it was College policy that "in the case where a learner who is deaf has the requirement of Irish Sign Language (ISL) interpreter, the cost of this will be borne by the learner". Griffith College did not offer to meet with complainant to discuss possible alternative arrangements with her in controversy with its

admission policy. In its decision, the WRC found that Section 4 of the Equal Status Act required Griffith College to evaluate complainant's needs. The WRC ordered Griffith College to pay complainant €3,000 for the effects of discrimination.
